Q (2) How can the stereotype that girls are a burden on their parents affect the life of a daughter? Imagine this situation and list at least five different effects that stereotype can have on the way daughters get treated in the house.

Ans

Ans →

Group A

We will make that person aware about cleanliness.

Group B

Observe basic rules of cleanliness and everyone will be friends with you.

Group C

We will say that persons that do not want to share food with a particular person is totally wrong.

(d)

Someone tells you a joke that makes fun of a community because of their accent (accent).

Ans →

Group A

We would try to convince those boys ~~and~~ girls not to get involved in the joke and we would proceed from their immediately.

Group B

A person should speak the language correctly.

Group C

Accept the person he/she may have learnt to speak in that accent from the beginning.

Ans →
